**GUARANTEE**

In consideration of the credit which Adheseal has agreed to extend to (.....) The undersigned Guarantor hereby guarantees the payment of all present and future indebtedness now due or owing or which may hereafter become due or owing to Adheseal by the customer and whether arising out of the sale of goods & wares and merchandise sold by Adheseal to the customer or otherwise howsoever, if the customer shall pay any amounts as aforesaid when due, the Guarantor promises to pay all of the said amounts on demand.

The guarantor hereby waives any requirement for notice of Adheseal's intention to enforce this guarantee and hereby further waives notice of default in the payment of any other of the said amounts, and that Adheseal shall be entitled to recover from the guarantor without first proceeding against the customer.

The Guarantor's liability under this guarantee shall not be released, discharged or in any manner affected by any of the following:

- Any time or indulgence being granted by Adheseal to the Customer or if more than one to any Guarantor
- Any or all of the said amounts being compounded, released surrendered or waived, with or to the Customer or by the allowance of extension of time for payment or conversion of the same from any particular form to any other form.
- The recoverability of the whole or any part of the said amounts being barred or estopped by a principal debt or obligation.

All composition and payments received by Adheseal shall be regarded as payments in gross and the right of the guarantor to be subrogated in respect thereof shall not arise until Adheseal shall have received the full amount of the customer's indebtedness. The Guarantor shall supply Adheseal with all information relating to directly or indirectly to the financial position of the guarantor as Adheseal may from time to time request.

This guarantee shall be an absolute and continuing guarantee which shall not be terminated by death of the guarantor but shall continue in force until Adheseal shall receive notice of revocation in writing from the Guarantor or the executors or administrators of the Guarantor, but such revocation shall not in any way relieve the Guarantor or the estate of the Guarantor from liability for the indebtedness contracted prior to the service of such notice, nor where there is more than one guarantor shall it be released from the other Guarantor.

Adheseal shall mean Adheseal Pty Ltd and its subsidiary companies.

This guarantee shall be construed according to Queensland law and the Guarantor hereby submits to the jurisdiction of the Courts of that place relating to any matter or proceedings contained in or arising out of this guarantee.
